In light of the expected lower returns for traditional asset classes, we believe our approach is differentiated from most multi asset solutions which are overly reliant on growth assets. In our view, our edge is underpinned by two pillars:

- ▶ **Enhanced diversification:** delivered through a truly broad investment universe that includes both traditional and alternative risk premia, with a strategic allocation based on macro regimes
- ▶ **Dynamic risk management:** delivered through a short and mid term strategy and more tactical opportunities, as we believe risk is multi-dimensional and more than just realised volatility

INVESTMENT APPROACH

Multi Asset Navigator adopts a three-step approach to navigating varying market conditions:



STEP 1 - STRATEGIC ALLOCATION: *Building an “all-weather” base*

Our research shows that the returns of risk premia vary over time and that their performance can be linked to different macroeconomic and market conditions. Therefore, we seek to build a portfolio that is robust across different macro regimes. Our long-term, strategic allocation is anchored around strong macroeconomic analysis, which has shown that the economic cycle can be split into four macro regimes: steady growth, recession, inflation shock and market stress. We create macro baskets with the risk premia which have historically best responded to the various regimes




STEP 2 - DYNAMIC ALLOCATION: *Quickly adapting to different market conditions*

Our dynamic allocation strategy is based on our proprietary indicators, “Nowcasters”, which assess conditions in real time and systematically adjust the portfolio’s asset allocation. Rather than relying only on a purely quantitative system, we complement this approach with qualitative analysis to determine relative value across and within asset classes. Furthermore, an important component of our approach consists of dynamically managing the risk level of the portfolio (Dynamic Risk Targeting). This is crucial as correlation shocks can create challenging outcomes for multi asset investing.



STEP 3 - OPPORTUNISTIC ALLOCATION: *Investing in specific short term opportunities*

Our opportunistic allocation aims to generate investment ideas outside the strategic and dynamic universe. These ideas should be either idiosyncratic opportunities, with low correlation to the rest of the portfolio and low directional market exposure, or absolute return in nature, with limited downside.




NAVIGATOR: THE MACRO RISK-BASED INVESTMENT STRATEGY


Strong performance since launch¹
